Notes

This is the second incarnation of a data set the Firearms & Explosive Licensing Unit (FELU) wish to publish on a regular (at least quarterly) basis.

This set of data is derived predominantly from information held within the National Firearms Licensing Management System (NFLMS).

This set will evolve as FELU in Devon & Cornwall Police continue to transition from an old IT system in use prior to February 2025 to its new system, Niche. As a result, this data is presented from several different systems used to monitor performance (Excel, QlikSense) – it is anticipated that as these systems embed a more consistent, single source data set will emerge. It should be acknowledged that, as the data itself refines and develops in fidelity, some of the presentation and/or content shown may update or change.

This data is published to demonstrate transparency and engage our customers and certificate holders.

112 Day Service Level Proposition

Following the Fee increase in February 2025 nationally an ideal service level has emerged for Firearms License applications that are non-complex to be completed within 4 months.

Within Devon & Cornwall we have refined this service level to consider work that, due to safety or other considerations, can and should be completed sooner or to account for factors outside of our control such as later submission.

The non-complex element is intended to promote safety and ensure there are no time limits applied to work which requires detailed and thorough investigation or research. This means, in practice, any work which suggests a license issue cannot take place at first pass will be deemed complex and not subject to the 112-day / 4 months.

The target suggested is 4 months, we have adopted a 112-day target (16 weeks) to remove the variable number of days in months and align more closely to how legislation is written.

The next 2 slides details the proposed service level and our current performance against it.





112 Day Service Level

All work to be complete within 112 days or the expiry, whichever is sooner.

Except:

- Complex cases (Safe)
- Renewals submitted < 7 weeks (late from customer, no statutory extension) (Sustainable)
- Application bot exceptions within 7 days to prevent data loss (Efficient)
- Change of address within 7 days (Safe)
- Transfers within 7 days (Safe)
- Transfer in initial processing and gross check within 7 days(Safe)
- CAT POLE alerts, information and intelligence within 24h (Safe)
- CLUB CHECKS with 3 months





Current 112 Day Performance

Last 6 months (BAU*) November 24 to April 25:

50% of all work completed in 56 days. (Previous 50%)
82% of all work completed in 112 days. (Previous 81%)
18% of all work completed over 112 days. (Previous 19%)

Renewals 46% (+4%) in 56 days, 88% (+1%) in 112 days, 13% (-1%) over 112 days.

Grants 44% (-4%) in 56 days, 55% (-5%) in 112 days, 45% (+5%) over 112 days.



^{*} Business as Usual (BAU), an internal definition of all work that was not counted as part of the (now cleared) backlog of grants and renewals.

This data is derived from NFLMS, as this products evolves the intent will be to publish more refined process data plus comparison.
